

Living Springs Publishers LLP Short Story Publishing Contract

PUBLISHING Agreement between
LIVING SPRINGS PUBLISHERS LLP (the "Publisher") and
%Author% (the "Author")
For %Story% (the "Story")
The parties agree as follows:

Author's Grant

1. The Author grants permission to include his/her story %Story%, hereafter referred to as the Work, in *Stories Through The Ages Baby Boomers Plus %Year%* an anthology to be published by the Publisher, hereafter referred to as the Anthology.

Rights

2. The Author grants the Publisher the right to publish this story in the English language in the anthology. It is also understood and agreed that the Publisher may use this Work only in the above-mentioned Anthology--both paperback and electronic editions--and re-printings of it, and that the Author shall retain all other rights to the Work not specified here.

The Publisher shall continue to have the right to publish the Book in any format without obligation or liability to the Author. The Author will be free to publish the Story in any other format the Author chooses.

Author's Copies

2. For the rights granted above, in addition to any prize money:

Authors residing in the United States will receive one (1) copy of the Anthology, which will be mailed within thirty (30) days of publication of the Anthology.

Authors residing outside of the United States, who reside in an area where Amazon is available will receive (1) copy of the Anthology, which will be mailed within thirty (30) days of publication of the Anthology.

Authors residing outside of the United States, who reside in an area where Amazon is not available, in lieu of a copy of the book, will be reimbursed the entry fee for their story.

Author's Warranties, Representations and Indemnities

3. The Author represents and warrants that he/she is the sole author of the Work, that the Work is original, and that no one has reserved the rights granted in this agreement. The author also represents, to the best of his/her knowledge, that the Work contains no matter unlawful in its content, nor does it violate the rights of any third party; that the rights granted in this contract are free and clear; and that the Author has full power to grant such rights to the Publisher.

The Author further warrants that any and all works submitted under this contract are not in the public domain and are not and have never been published in paper or any other format with any publishing company that may still own proprietary right to the Work.

The Author agrees to hold Publisher harmless and indemnify it from all damages, costs, and expenses directly resulting from a finally sustained judgment relating to any legal actions incurred by the Author arising from a breach of the above warranties.

Changes in Text or Title

4. The Author has the right of final approval of his/her manuscript. However, the Publisher may suggest editorial changes. The Publisher shall have sole control of all formatting, cover art, and content of the Book.

Authors Credits

5. The Author will be credited on the book cover, in the table of contents and in an Author's page following the Story.

Venue

6. This agreement shall be deemed executed under the laws of the state of Colorado, United States of America. Colorado State Law shall be the applicable law of this agreement.

Reversion of Rights

7. In the event that the above-mentioned anthology has not been published within four (4) months of signing of this agreement, all rights revert to the Author, and the Author has the right to sell or arrange for publication of the above-named Work in any manner.
